

Membership Committee

Previously known as the Publicity and Marketing Committee, this group has reorganized and is now called the Membership Committee. In turn, Eugene Bissell has adopted the new title: Branch Registrar.

The aim of the Membership Committee is to discuss issues and provide support to the Branch and its members regarding new member recruitment and membership retention. The Membership Committee functions as a standing committee of the Branch, reporting to the Branch Committee and implementing projects so approved.

Co-chaired by Connie Wai and Bradley Hobbs, the committee is supported with the help of Susie Langdon Kass (head of Publicity Committee) and Eugene Bissell (Branch Registrar). Given busy and conflicting schedules, much of our discussion is conducted through e-mail or telephone to facilitate action. We meet every other month, or as required, to further discuss issues.

The Membership Committee encourages participation by the class managers as representatives of the many Branch classes. Any member of the Branch is also welcome to approach members of the committee with comments or suggestions for increasing and retaining membership.



Branch Committee Actions

March and April, 2002

Events

Asilomar: In March, Marianna provided a first look at the 2002 event. She has had a very good discussion with Asilomar management. Due to increased costs, prices will rise to \$280 this year. The Committee reviewed the 2002 budget and approved it. There was further discussion about which weekends to request for future years and it was agreed that weekends in October are preferable to weekends in November. It was also noted that, this year, the weekend will happen on the first weekend in November; therefore the November monthly party will be moved to the following weekend. Marianna also reported on her correspondence with Asilomar regarding the surprise energy surcharge associated with the 2001 weekend. The Asilomar management acknowledged

their error and assured the Branch that it will not occur again.

Valentine's Ball: At the March meeting Art reviewed the registration process and preliminary results. The Committee discussed various aspects regarding attendance and the possibility of doing a survey of the membership to get feedback. The Committee appointed Art Tarsa as event chair for the 2003 with distinct enthusiasm. The Committee also expressed deep thanks to Cecila Grote, the outgoing chair. In April, Patti reported that the survey had been successfully prepared and included with the mailing of the Branch ballots. Art presented the 2001 Valentine's Ball Final Report. The event had a deficit of approximately \$1,300 compared to a planned deficit of \$845. The difference was primarily attributed to a somewhat lower than expected attendance. He also reported that for the 2003 ball, Pat O'Brien has agreed to chair the program Committee and that Fiddlesticks and Ivory have been retained. Other members of the Committee include Judy Glickman and Cecilia Grote.

Jean Patrick Dance: In March, Larry presented the preliminary budget for the 2002 dance. In April, Larry reported that the dance will be held at the Veteran's Hall in downtown Pleasanton this year. This venue is less expensive than the alternative, has a better floor and is close to downtown restaurants, but is smaller and not air-conditioned.

Treasurer's Report

In March, the Committee decided not to consider a change in the Branch portion of membership dues this year. The Committee will review monthly party pricing at a future meeting, after the venues have been selected. In April, Gary provided a preliminary report of the results of the fiscal year that ended on March 31, 2002. It appears that the Branch will suffer an \$8,500 deficit for the year, divided fairly evenly between event deficits and administrative deficits. The Committee agreed to review monthly party ticket prices at the June meeting and to discuss the larger budget issues starting in October. Gary also reported that the South Bay Children's class has repaid one third of its startup loan.

Committee Activities

Nominating Committee: Larry reported that four candidates were up for election to four open positions. Patti

and Gary agree to oversee the counting of the ballots at the AGM.

Marketing/Membership: In March the Committee reviewed the document that Bradley had distributed at a previous meeting. The Committee is directing their efforts at membership retention and recruitment. Because of this, they would like to be known as the Membership Committee. To avoid confusion it was suggested that the role currently known as Membership held by Eugene Bissell be renamed Branch Registrar. In addition it was agreed that both the Registrar and members of the Publicity Committee should be automatic members of the Membership Committee.

Other Items

Music Fund: In April, Dan reported that Nancy and Gene Bissell had implemented the check-off item on the membership renewal form. Given that the check-off item is on the form, and that it is clear that the de Lemos fund is available for the support of live music, we need a mechanism for members to take advantage of the opportunity. As his effort for the Santa Cruz class was considered to be a good example of that, he will write up the project for the *R&S*. It was suggested that he include the key points of the Santa Cruz application which made it appropriate for funding by the Branch. The Committee also discussed finding a way to make copies of "Leaves of Cabbage" available to Branch musicians.

Bylaws Update: The Committee discussed various aspects of the Bylaws update in March and April and agreed to wait until the AGM in 2003 to present a proposal to the Branch membership. In a related discussion, the Committee discussed conducting the poll on briefing again this year. The consensus was that every year was too often, but that it would be good to find out how the membership felt about the policy so far. Therefore, the Committee decided to conduct the poll again this year, and every other year thereafter.

Teacher Tutor Job Description: The Committee worked on a draft of the Job Description and forwarded it to the Teachers' Committee for their final review. The document has now been adopted by both Committees and is available on the Branch website.

Selection of Branch Representatives for Scotland: The Committee confirmed Alex Tweedly and Robert McKay as Branch representatives and asked Nancy to invite David Normand Harris to be our third representative. It

was also suggested that it would be prudent to have an alternate available. In April, Patti reported that we now get six representatives, so we need two more. She agreed to canvas the attendees at the monthly party and inquire with our current representatives in Scotland to get suggestions.

Guidelines for Children: Sheena MacQueen and Kathleen McAdam presented the updated Children's Activities Policy from HQ and said that we needed a new Code of Practice to match. There was a discussion of the HQ document; Kathleen and Sheena said that they would provide a new policy for the Branch based on the HQ document with appropriate changes.

The Committee went on to discuss the proposed "Guidelines for Children Dancing with the Royal Scottish Dance Society San Francisco Branch" and other documents provided. It was noted that the definition of "children" (under 16) may not meet the needs of the Branch and the use of the word "minors" was suggested instead. There was considerable discussion of the guidelines. It was noted that the document addressed a variety of issues beyond the safety of minors that related to the character of RSCDS events. Dan suggested that the document might be better if it was organized around principles rather than rules for specific events. For example, the principles might include the requirement that children receive parental permission to attend RSCDS events, that adult attendees should, in the main, be aware of and supportive of the presence of children if children are to be included and that children's safety must be paramount. The representatives of the Teachers' Committee agreed to present the comments of the Branch Committee to the Teachers' Committee for further discussion.

Request for materials to support the Pleasanton Games: Miriam reported that at the last Pleasanton games she had noticed that several of the tarps and clamps were in need of replacement. The Committee authorized the expenditure of up to \$100 to buy new items as needed during the setup of the game tents.
